### Questions

1. Is there any benefit for the investor to purchase discounted Icelandic Krona?
2. If the answer is yes, then is the discount of approximately 50% of the current rate of exchange and acceptable investment.
3. If both answers are yes, then does the investor have a problem with doing the transaction through his own financial Institution.
