The pump was cleared yesterday and crossed the border last night, 5/1/17. Per Darcy, it will take 5 business days to arrive in Medley, FL - estimated arrival Tuesday, 5/9/17. If there are no Customs issue in FL, estimating sail date of Friday, 5/12/17. Estimated arrival on STT Tuesday, 5/16/17. Clear Wednesday, 5/17/17, on LSJ by Friday, 5/19/17.

Barring any delays with trucking or Customs - Friday, May 19th on island.

Joseph Wilburn of CH Robinson spoke with Ms. Greenberg at Tropical Shipping. Tropical Shipping cannot provide a Tax ID for this cargo as they are only an ocean carrier, and cannot act as the US Principal Party of Interest.

We will use Janusz's name, his Tax ID and the PBI address to clear and move the pump to Florida. From there Tropical will use Janusz's Letter of Authorization, which they have on file, to move the pump from Florida to STT.
