Hi Jeffrey,

Thanks for your time on Thursday, I appreciated your advice and have taken everything you said on board.

I wanted to tell you about the conversation I had with Charlie today. I drove up to his upstate property and we had lunch. He offered me the role of business development manager; where I would represent his brand and look for opportunities for him that sit outside his Bloomberg show. The role we discussed was multifaceted:

1. Develop a number of television series - He wants to do a series on China and a series on Japan and proposed that I raise the money and help produce both series.
2. Following up on ignored opportunities - He said that he is constantly approached by different organisations that want to develop conferences and television series with him (Microsoft, AOL, Stanford University, etc), but he hasn't had the time to follow up on any of these opportunities.
3. Develop my own ideas - Whether it be a specialised conference, or television series, that could be independently funded.
