IMDx employs experts from diverse backgrounds including financial, legal, scientific, and medical, and is run in a unique manner such that all are involved in product development from initial concept stages to commercialization. Dr. Jacobs works hard to ensure the highest quality products are produced at IMDx and accurately reflect the needs of the global medical community. Through the creation of IMDx, Dr. Jacobs is achieving her goal of improving the relationship between patients, physicians and diagnostics. Dr. Jacobs is a woman to watch as IMDx grows and expands its menu offerings, becoming a larger player in the molecular diagnostics industry.
