-Users can share this information (or opt-out) with other users (Facebook style) to get examples and templates of what works for real women over a broad range of lifestyles.
-Diet Management and weight loss services are a massive but deeply fragmented market (\$61bn in the US, ~\$586bn globally). Online sales are growing quickly and tremendous potential for mobile.
