Dear Yfke,

Please note the following.

In 2011 we came to the conclusion that Elite would not keep their promise with respect to MTA and the shareholdership in Elite Amsterdam. I did the negotiations with Andrew Gleeson. Andrew and I did not come to any conclusion, so we had to find a lawyer who was capable to force a solution. Since Radboud joined GT in October, I advised Imad and BST to hire Radboud, which they did. The payment to Radboud was agreed by BST and NAI, the two remaining shareholders of Model Connexion. The accounting and the instruction of the accounting was put under my responsibility. The accountant was asked for a forecast of the costs and we (BST and NAI) agreed on this amount. That's the reason why we could reserve this payment.
