

- Any correspondence with Zwirn concerning FTC, Jeepers, or Epstein, including anything related to their redemption rights and/or efforts to redeem;
- Any documents concerning the various irregularities in the management and record-keeping at Zwirn (excluding information that was sent to all investors);
- A copy of the 2007 Agreement between Zwirn and Dubin concerning the buyout of [REDACTED] interests in the general partner of the fund and any related entities;
- Documents indicating any payments made to Dubin and/or Highbridge;
- The 2004 “wind-down” agreement for the Highbridge managed account at Zwirn;
- Documents that would show the amount of Highbridge money held by Zwirn in the fall of 2006, and documents reflecting withdrawals from that point forward;
- Documents showing the withdrawal requests made by Highbridge; and
- Documents showing the current value of [REDACTED] personal (either individually or through a related entity) holdings in Zwirn.
