Mr. Critton:

We now represent ██████████. Without getting into unnecessary details regarding her experience with your client, I have included the relevant facts below to assist you in evaluating and resolving her claim. ██████████ date of birth is ██████████ and she was 15 years old when she was taken to Mr. Epstein's home by ██████████. She was lead upstairs into Mr. Epstein's bedroom where he appeared naked and asked her to begin massaging him. After several minutes, he rolled over and began grabbing ██████████ buttocks. Mr. Epstein began masturbating and reached up and grabbed ██████████ breasts. At that point ██████████ became angry and asked to leave. She left and was upset with ██████████ for not informing her that Mr. Epstein was going to try to touch her in that way.

██████████ then told ██████████ that Mr. Epstein was sorry for her last experience and wanted her to return. ██████████ assured ██████████ that nothing weird would happen the next time, and specifically told her it would only be a massage. ██████████ returned a second time to Mr. Epstein's home and was again taken upstairs into his bedroom, where he appeared naked and requested ██████████ to begin massaging him. After several minutes Mr. Epstein turned over and began masturbating. He reached up and grabbed ██████████ breasts and she immediately told him not to touch her. He then grabbed her buttocks in an aggressive manner and ██████████ pulled away and told him that she was leaving. Mr. Epstein was visibly angry, and told her to leave as he walked into the shower.

If you were to investigate ██████████, you would find that she has a clean background, no sexual experience prior to Epstein, and no significant other traumas in her life. Mr. Epstein's criminal conduct against ██████████ has caused emotional and psychological damage to ██████████. She deserves fair compensation for her injuries in an amount that also addresses the punitive nature
