SUMMARY

Upon request, I conducted surveillance on [REDACTED] on Friday, January 29th, 2010 and Saturday, January 30, 2010. I observed Ms. Miller on Saturday, January 30, 2010 where I determined she is employed at [REDACTED]. Below you will find the details of the investigation during this time period.

SURVEILLANCE DETAILS

Friday, January 29, 2010

5:30 pm Arrived at [REDACTED] in search of subject's vehicle. In the absence of the vehicle, investigator returned to the address on house at [REDACTED]. Subject's vehicle was not there either. I

returned to [REDACTED] and confirmed with some children playing outside that subject resides in [REDACTED] with [REDACTED]" but her vehicle was still not there. I then proceeded to the downtown West Palm Beach/Clematis area. I continuously searched for subject on Clematis searching Rocco's, Roxy's (rooftop & 1st floor), Bradley's & Dr. Feelgoods (1st and 3rd floor as there was a private party on the 2nd floor). Rocco's was the only place packed and all the other bars were empty. My last stop for the evening was Dr. Feelgoods which I left at approximately 11:15 pm without having found subject, surveillance was suspended for the evening.

Saturday, January 30, 2010

8:30 am Drove by subject's residence at [REDACTED] and observed subject's vehicle in a nearby parking space. Vehicle photographed.

5:30 pm Arrived at subjects residence at [REDACTED]. Observed subjects vehicle parked near the building. Surveillance resumed.

6:30 pm Observed subject as she exited the apartment and followed as she travelled in her vehicle west on Summit Boulevard, then North on Military Trail to Okeechobee Boulevard then East onto [REDACTED].

6:39 pm Subjected arrived at [REDACTED] and I observed her vehicle parked in the parking lot of [REDACTED].

8:00 pm Entered establishment "[REDACTED]" on [REDACTED] in search of subject.

9:30 pm After observing all of the ladies at [REDACTED] had rotated through their stage performances and there being no sign of the subject, I exited [REDACTED] and observed that subject moved her vehicle from the area of [REDACTED] and parked it directly to the right of the establishment "[REDACTED]".

10:10 pm I inquired about their services, we were next door and wanted to know what you charged. I was advised by a black female that they charged [REDACTED] per half hour. I asked if I could see all the girls and she allowed me to see 3 of the girls and said that the last girl was busy at the moment and to return later.

11:00 pm Returned to [REDACTED] and the last girl came out and said her name was [REDACTED] but she was busy at the moment. I identified [REDACTED] as [REDACTED].

11:30 pm There being no further movement, surveillance was suspended for the evening.
