Hi Peggy.

Spoke to a couple of my colleagues in ENT. The first thing your friend, Stephen Daldry, has to do is to establish whether this is a sensory neural hearing loss versus a conductive hearing loss. One is treated with surgery and the other is treated with a hearing aid. The way to establish the difference is by doing a hearing test. That can easily be done by calling Dr. April's office, [REDACTED]. Say that Dr. April recommended for him to have a hearing test and make sure you let me know so I give them a heads up. They will take very good care of him. If he has already done a hearing test you can fax me the results [REDACTED] and I will get it to the right people to find out in which direction to go from there. If he already knows that it is conductive hearing loss and that surgery is indicated the top

guy for that would be Tom Roland at NYU.
