I spoke to Chris at length tonight, he said that Sikorsky feels we should show good faith in closing on the current C++, at that time they will negotiate a better price on another C++ for you,

Chris reiterated that Shmitka is being accused of being brokers and they hesitate to show us a low price, plus we are using this closing as a negotiating tool,. He told me that Mark Poloand (Director of Commercial Sales for the Americas') has his monthly meeting later this week with Jeff Pino the President of Sikorksy, to review sales and closings, both are aware this C++ has not closed. Chris informed me that He and Howard asked Mark Poland to delay turning this over to their legal department at this time with hopes this will close, and keep a good relationship with you. Mark Poland and Jeff Pino are aware of what has happened in the past with this delivery schedule and what Chris has given us. Chris said Sikorsky has met all of our request for closing including the additional 20K discounts, and cannot understand why we are not closing, they are very upset (actually the word he used was Pissed) according to Chris, he said this has to close tomorrow morning,.(his words) as always Chris was very cordial but wanted me to know Sikorsky's stance before this goes to its legal department.

Reenstra has not been paid his commission according to Chris also...

Sikorsky is well aware of your dissatisfaction with the first S76B and S76C++ that you owned and wanted this one to be right.
