Jeff,

I know this is difficult to bear, but please understand that because information pipelines have become basically free, we have rapidly gone from an Age of Information into an Age of Misinformation and downright Disinformation, where people can propagate anything that they wish very quickly. The replacement of the mug shot, etc., on the top of the wiki page was a big deal as it was the first thing you saw. Most of that crap is gone now. Try to see some of the positive results that we have worked so hard on. It isn't easy.

Speak to you tomorrow. I have that uber hacker coming over tomorrow and we have some more things we are pulling out this week in this department.
