On the sale side we are really good...In Vivendi/GVT eg., Shaul Shani (GVT majority shareholder) had an offer from Goldman for a secondary IPO (about 22% to be sold) valuing the entire GVT usd 2.4 bn. After I met Mr. Shani, he revoked their mandate (paying them a break-up fee) and signed up with us. Short later we sold about 80% valuing the entire company usd 4.2 bn.
