The owners want \$650.00 per tree, all removing and transporting equipment must be provided by the buyer, they have contacts to refer to, but they don't involve them selves in that aspect.


As this pictures shows, the palms are very tall, most over 25-30ft, they are also very poorly maintained, no water, and no fertilizer Ever!




