- A. SINCE SEPT 11 2001, GENERAL AVIATION ACFT HAVE BEEN BANNED AT THIS AIRPORT. HOWEVER, THE U.S. GOVERNMENT HAS AGREED TO ALLOW GA FLIGHTS BACK INTO REAGAN NATIONAL/KDCA UNDER SPECIAL GUIDELINES.
- B. AIRCRAFT OPERATORS MUST:
- FOLLOW A STRICT SECURITY PROTOCOL TO INCLUDE PASSENGER AND BAGGAGE SCREENING AS WELL AS CRIMINAL HISTORY RECORD CHECKS FOR THE PILOTS.
 - A LAW ENFORCEMENT OFFICER MUST BE ONBOARD EVERY FLIGHT.
 - PROVIDE AT LEAST 24 HRS ADVANCE NOTICE OF THEIR INTENT TO USE KDCA.
 - ARRIVE FROM ONE OF 15 PORTAL AIRPORTS IN THE U.S.:
SEATTLE-TACOMA/SEA / BOSTON LOGAN/BOS / HOUSTON HOBBY/HOU
WHITE PLAINS/HPN / LAGUARDIA/LGA / CHICAGO MIDWAY/MDW
MINNEAPOLIS-ST PAUL/MSP / WEST PALM BEACH/PBI
SAN FRANCISCO/SFO / TETERBORO/TEB / PHILADELPHIA/PHL
LEXINGTON/BLUE GRASS/LEX.
