Good Morning Jeffrey,

I wanted to share some time-sensitive information regarding Acqua Liana and 700 S. Ocean (5.57 acres/520' of direct ocean-to-Intracoastal vacant land).

In the event we do not secure a contract for purchase and sale between now and January 1, 2010, we will be significantly reducing the price of Acqua Liana from \$29 million to **\$24.3 million**. The new price of **\$24.3 million** would represent between \$1.2-\$1.7 million below current appraised value (as you know, we have two recent appraisals, one for \$25.5 million, the other for \$26 million). We will also be reducing the price of 700 S. Ocean from \$34.3 million to **\$32.9 million**. **\$32.9 million** is \$10 million less than the initial offering price.

As you have expressed an interest in Acqua Liana and/or 700 S. Ocean, I wanted to let you know before the new **\$24.3 million** and **\$32.9 million** prices are made public so that you might take advantage of this substantial reduction.
