Low frequency current is limited through the transformer eliminating low frequency saturation. Automatic Saturation Compensation allows many speakers to be run on a distributed line with a 50Hz Hi-Pass filter before the amplifier, regardless of the number of speakers on the same line (the number of tapped watts cannot exceed the amplifier rating).
