WEST PALM BEACH — Just when billionaire sex offender Jeffrey Epstein thought he had put most of his legal woes behind him, a woman Friday sued him in federal court for paying her for sex when she was 16. Identified only as M.J., the woman is seeking more than \$50 million from the 57-year-old part-time Palm Beacher. She is also asking a judge to force him to post a \$15 million bond because she says he is putting cars and aircraft in other people's names to protect them from seizure and could move his money offshore. Epstein earlier this year settled lawsuits with more than 20 women.
