NOTICE OF JOINT VOLUNTARY DISMISSAL OF JEFFREY EPSTEIN

Pursuant to Rule 41(a)(1)(A)(i), Federal Rules of Civil Procedure, Movants, Farmer Jaffe Weissing Edwards Fistos & Lehrman, Bradley J. Edwards, and L.M., hereby voluntarily dismiss their respective Motion's for Contempt against Jeffrey Epstein without prejudice.

Upon completion of the limited discovery permitted, it is apparent that the party responsible for the violations of this Court's November 30, 2011 Order is Fowler White, while acting in its capacity as legal counsel to Jeffrey Epstein. 
