To Whom This May Concern,

Please accept this letter as a written public records request for inspection and copying of the following public records:¹

Copies of any and all correspondence with regard 515 North County Road, Palm Beach, Florida from 2003 - 2009.

Atterbury, Goldberger & Weiss, P.A. agrees that it will compensate you for the actual cost of duplication of any of the records which it has requested. If the nature or volume of the public records requested is such to require extensive use of information technology resources or extensive clerical or supervisory assistance by personnel of your office, Atterbury, Goldberger & Weiss, P.A. agrees that it will compensate you for those costs as well, subject to the terms enumerated herein.

Please note that Section 119.07(2)(a) of the Public Records Law provides that a person who has custody of a public record and who asserts that an exemption applies to a particular public record or part of such record shall delete or excise from the record only that portion of the record with respect to which an exemption has been asserted and validly applies, and such person shall produce the remainder of such record for inspection and examination. This Section further provides that if the person who has custody of a public

¹The term "record(s)" as used herein shall mean "all documents, papers, letters, maps, books, tapes, photographs, films, recordings or other material, regardless of physical form or characteristics, made or received pursuant to law or ordinance or in connection with the transaction of official business by any agency".


record contends that the record or part of it is exempt from inspection, he shall state the basis of the exemption which he contends is applicable to the record, including the statutory citation to an exemption created or afforded by Statute and, if requested by the person seeking the right under this subsection to inspect, examine, or copy the record, he shall state in writing and with particularity, the reason for his conclusion that the record is exempt.

It is hereby requested, on behalf of Atterbury, Goldberger & Weiss, P.A. that you do state in writing both the statutory citation to any exemption which you claim applicable to any requested record and the specific reasons for a conclusion that the requested record is exempt.

Also, please note that Section 199.07(02)(c) prohibits the destruction of any of the requested records, including any which you claim are exempt, for a period of thirty (30) days after the date on which you receive this written request. If a civil action is instituted to enforce the Public Records Law, with respect to the requested records within the thirty (30) day period, you may not dispose of the records except by Court Order after notice to all affected parties.

Upon locating the requested documents, please contact this office and advise me of the actual costs of duplication or any necessary staff research time and I will be happy to forward a check for that amount. If you have any questions, please do not hesitate to contact me. Thank you for your cooperation and consideration in this matter.
