**ORDER GRANTING MOTION TO PERMIT BRADLEY J. EDWARDS TO TAKE THE
LIMITED DEPOSITION OF JEFFREY EPSTEIN**

THIS CAUSE having come to be considered upon Bradley J. Edwards' ("Edwards") Motion to Permit Bradley J. Edwards to Take the Limited Deposition of Jeffrey Epstein, and the Court, having reviewed the file, considered the arguments of counsel, and being fully advised in the premises, it is hereby ORDERED and ADJUDGED that the motion is **GRANTED** as stated on the record and summarized as follows:

Edwards may depose Jeffrey Epstein ("Epstein") regarding the following topics related to the 700+ exhibits disclosed by Epstein on the eve of trial, which include materials to which Edwards has asserted privilege, as well as reasonable follow-up questions related thereto:

1. Whether and to what extent Epstein reviewed any of the documents prior to March, 2018;
2. Whether and to what extent Epstein reviewed any of the documents after March, 2018;

3. Whether and to what extent Epstein has complied with the Court's Order striking the exhibits and ordering all copies, in any form, to be destroyed;
4. Whether and to what extent Epstein has shared any of the documents, including specifically any privileged materials, with any third-parties; and
5. Which, if any materials derived from the 700+ exhibits that Epstein plans to use or rely upon at trial. Epstein may avoid questions on this topic if there is a stipulation on the record that he is not testifying at the upcoming trial.
