

Dear Mr. Link and Ms. Rockenbach:

Your Proposal for Settlement of January 11, 2018 is hereby rejected. Bradley Edwards will never sign a document from which it may be inferred that Epstein ever had a reasonable basis upon which to dispute the claims made against him by Bradley Edwards, that releases any claim except the specific claim currently pending, or that suggests the payment of millions of dollars to Bradley Edwards should "not be construed or interpreted as an admission of liability on the part of Epstein." Furthermore, Epstein has not expressly denied liability. He has consistently hidden behind his Fifth Amendment right to remain silent. Bradley Edwards will never sign a document that contradicts that reality.

The imposition of those unacceptable conditions in your Proposal for Settlement—conditions unattainable in any judgment—render the Proposal unenforceable in the highly unlikely event that other conditions for its enforcement would ever be met.
