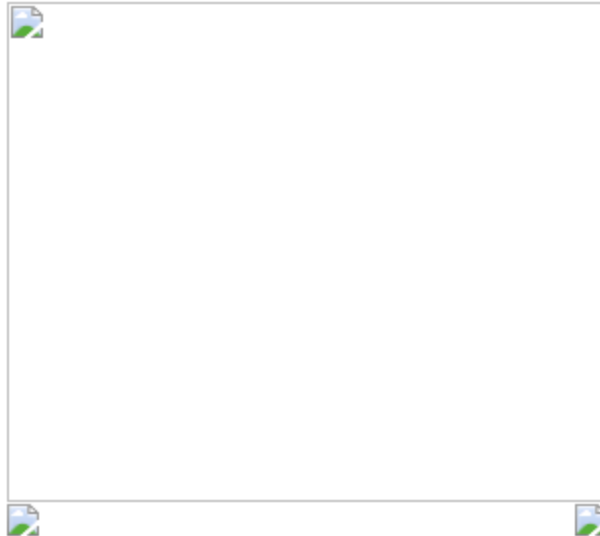
Donald J. Trump was caught on tape bragging in vulgar terms about making sexual advances toward a married woman, and aggressively kissing and groping other women.
