We have connected with your respective family offices and accountants earlier this week to update them on the timeline for the historical form 8865 (and attached 8858) data for the underlying investments of BRH Holdings L.P.. Deloitte has committed to completing the last 3 years (2012 to 2014) by October 15th. During that time they will update us on the timing of the remaining years going back to 2007, with the intention of completing everything by the end of October.

All of the family offices and accountants were in agreement with the timeline and indicated that they do not have the capacity to complete the historical filings until they finish the 2015 tax filings first which are due 10/15.
