Jojo and Karyn were informed today by oncologist that Lynn's days are numbered to weeks and at best a few months
Lynn did not look great as she could barely talk and was very tired from all the morphine - I think her lack of expression was due to stroke she suffered over the weekend

Jojo showed me paperwork he signed today for Hospice which will be covered by their health insurance
They plan to move Lynn to their long island home Thursday.
Hospice will be coming tomorrow to set up bed and all other medical needs at long island home

They stopped lynn's lupus medication and she has had blood transfusions as her blood is not clotting well
Jojo shockingly was composed and temperament was ok and wanted me to update you on lynn status
