Please see the attached LOI for Larry's and JEE's approval:

1. Purchase Price \$17MM, plus the 727
2. \$1MM Deposit 2 business days after Seller's acceptance of LOI
3. Cash balance at closing and delivery of 727 at closing
4. AIC Title is the Escrow Agent
5. Subject to execution of definitive purchase agreement. Purchaser to provide first draft within 10 business days after LOI acceptance. parties to sign within 15 days after LOI acceptance (unless extended by mutual agreement)
6. BBJ and 727 each to be delivered with good title and each to be delivered in Airworthy Condition
7. BBJ and 727 each also to be delivered in accordance with the "Delivery Condition" to be specified in the purchase agreement
8. BBJ to be delivered with an Export Cert of Airworthiness from UAE GCAA to the US.
9. Transaction is subject to Seller's discretionary satisfaction with pre-purchase inspection of 727
10. Transaction is subject to Purchaser's discretionary satisfaction with pre-purchase inspection of BBJ
11. If either rejects, deal terminates and money is refunded to Purchaser
12. If both accept subject to correction of discrepancies deal moves forward, but if Seller fails to correct Aircraft Discrepancies of \$500K or less or Purchaser fails to correct 727 Discrepancies of \$500K or less, then the party who fails to correct, bears the other party's inspection costs.
13. August 31 set as acceptance deadline.
