Attached is a very preliminary set of plans based on our conversations and direction from Amy. The structural engineer hasn't reviewed, he will as the design gets closer to fruition. Sheet 4 is for the plan and profile of each dock, what is shown is not for this project - NOAA has not verified the water levels for July 20 yet, so the contours will all change slightly.
