14 - Unsold Lots And Sales After The Auction

a) Sales after the auction

If any lot is unsold at auction, you appoint us as your exclusive agent for a 60 day after-sale period after the auction to sell the lot privately for no less than the reserve and under the terms of this agreement. For post-auction sales, during this 60-day after-sale period, all

references to "hammer price" in this agreement will be read as if they

mean the sale price of the relevant lot. b) Collection of unsold lots

If any lot is unsold after the expiration of the after-sale period, and we and you do not mutually agree in writing that the lot will be re-offered by us in a future sale, then we will return the lot to you at your address set forth in Part 1 of this agreement. If, however, due to your actions or due to your failure to act, we are prevented from returning the lot to you within 30 days of your receipt from us of written notice of the intent to return the same, which notice shall be sent by us following the expiration of the after-sale period then, unless otherwise agreed by us in writing, we may, in accordance with the terms set forth on <https://www.christies.com/about-us/contact/storage-conditions/>, remove the lot from our premises and store it at an offsite location disclosed to you in said notice, re-offer and sell it, or we may return it to you at your risk and we may charge you our reasonable costs, expenses and fees for doing so.
