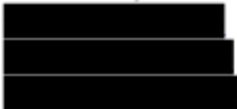

Good afternoon All,

I called Mr. Jose Diaz, Sr. yesterday and left a detailed message on his VM. I left both my cell and the office numbers however, he has not called me back. I just called Mr. Jeffers and asked him to convey the following message:

1. There is no signed contract
2. There is no provision for a cancellation fee in the unsigned contract.
3. At no time either in writing or verbally did Better Roads give notice that there was a cancellation fee.
3. That I know of, there is no VI law that states that a cancellation fee can be charged (as he alluded to in our conversation yesterday with the term "common and customary").
4. If they do not willingly refund the \$76K and the unused portion of the deposit, they will be sued.
5. If sued, they will spend more than \$76K in legal fees and still have to refund the cancellation fee.
