While the [ISO 4217 currency code](#) for Special Drawing Rights is **XDR**,<sup>[1]</sup> they are often referred to by their acronym **SDR**. Both refer to the name "Special Drawing Rights".

Intentionally innocuous and free of connotations because of disagreements over the nature of this new reserve asset during its creation, the name derives from a debate about its primary function—money or credit.<sup>[8]</sup> While the name would offend neither side, it can be argued that prior to 1981 the XDR was a [debt security](#) and so a form of credit.
