Upon the occurrence of an Event of Default, default interest in the amount of 10% of the original principal balance of this Note (the "Default Rate") will be deemed to have accrued and be immediately due payable, and thereafter default interest on the unpaid Obligations due and payable under this Note shall continue to accrue at the rate of 10% per month until all due and payable Obligations are paid in full.
