Darren,

We are astonished by your last proposal which is totally unacceptable for us.

We do not agree either to participate in the freight costs nor equip the boat with engines at our cost.

You misuse our good will, therefore we are forced to charge you for storing of the boat since 24th October 2014 i.e. date when the boat was ready for collection.

The storing fee is 45 EURO per day, so totally 272 days gives the amount 12.240 EURO.
