Each 55 gallon drum covers 2200 sq ft with a 2" depth and costs 1500 per drum
Shipping also needs to be included from CA to FL then Tropical (est cost 600)
Time frame to receive on STT is 16-18 days

Total projected Cost for 2 Drums = 3,600

Another item we will need to lay material is:

1) Purchase or rent a rototiller attachment (approx cost 1700 plus shipping)

We will need to do more research and receive input from staff to determine best unit to purchase
