spoke with Mercedes dealer

- 1) bentley was valued at 25,000 - they said it needs an entire front grill (5-6k) and is dented all over
- 2) escalade - i was able to based on 25k bid push up their bid from 82k to 85k (85k bid stands firm even if we do not trade in bentley)
- 3) maybach - all cars are being sold at full MSRP due to demand - that may change but not in first year of release per Gary
