Regarding money due Henry and loan documents  
I can not acquire the loan with the terms you have given  
RUSSELL has told me from the start and advised me - if he is not the first behind the Commercial lenders  
also listing his original 98k loan - there is no loan  
If david can acquire a loan under these conditions- I suggest you take it

As far as the 28k still due the restaurant from the original money the restaurant lent the hotel - First I  
appreciate the 20k sent Friday

I have not asked Russel if he would except - as you offered - having the hotel pay the remaining 28 k on April 9 — but before I try to extend this payment to April 9; let's see if we are going to agree on the terms of the needed \$100 k loan note -

Fyi Russels wife is very sick and I can't put or do not want to add any additional pressure on him For me. The 50k loan doesn't really help - I am not sure if I need all 200k as originally requested - but with out at least 100k the \$50 k loan is useless

As sown in documents sent last week - at prime costs we are almost at break even -but the weather - one of the largest factors —3 storms. In 2 weeks makes it almost impossible to achieve our needed goals - and the cold weather still continues

The 100k - depending on the weather should get us into some part of April - where- as long as the weather turns for the better we should start to break even

As it stands now we are losing 10-15k per week - which we should be able to meet- or succeed -with a little weather and review luck

We are also waiting for additional reviews - we know Adam platt has been in - as he has posted regarding But

The restaurant will be 30k overdrawn by Thursday this is even after receiving the 20k

I have reviewed with SR Mgmt - and the plan is - so we give you heads up - But if we can not finish all documents on Monday

At the end of service on Wednesday - we will close the restaurant

Some staff will stay on board to remove garbage and clean the space- at some time after- I will surrender the lease

Only SR Mgmt of Henry is aware so please do not say anything to any other HENRY staff and advise your hotel staff of same - I need these employees to finish Wednesday service

I really do not understand how david has put millions upon millions of above budgeted debt on the hotel - before any investors are paid back — yet you do not want to

1- repay in full a loan that was given to the hotel from the restaurant —balance due 28k

2- at least an additional \$ 100 thousand dollars in debt to the hotel —to try to keep the restaurant open till the warm weather hits -
