Here is a revised Invoice

Technical opinion :

Existing setup has multiple issues :

1) Electrical circuit needs to be inspected, given the fact 2 AVRs blew within couple of month, there might be some strange spikes or shorts in the electrical feed

Existing Monster Cable power conditioners are not surge protectors and will not protect the equipment in case of electrical spikes - I recommend to replace it with new generation of surge protectors from Surgex

2) Crestron - this system is not very stable and requires frequent maintenance

RTI control is user friendly with very solid performance at half a cost

This is latest, just introduced, product

3) Shutters and lights

Shutters control is very simple - contact closure control, we can implement easily

Lights - I could not find a Main Repeater (the brain) of the system, we need to determine what system is used
- Lutron Radio Ra 1st generation or Radio Ra2
Difference is in the drivers (older drivers might not work with new control system)

4) BluRay - this system deserves better BluRay - existing entry level Sony will not output best possible HD picture, we suggest to get oppo BluRay - one of the best BluRay manufacture ever.
