DRAFT letter to Buzzfeed

To whom it may concern:

I am writing as litigation counsel to Professor Lawrence Krauss. It has come to my attention that Buzzfeed has engaged in an outrageous and protracted defamation campaign against Professor Krauss, both in the form of libel and slander. Buzzfeed's campaign has been malicious, and undertaken with absolute reckless disregard for the truth. Your defamatory efforts have also been undertaken, for reasons known only to you, with the intention of tortiously interfering with the contracts of Professor Krauss, and Buzzfeed has unfortunately succeeded in this malignant purpose. We have both testimony and documents from a litany of well respected third parties that provide overwhelming evidence of Buzzfeed's malfeasant attacks on Professor Krauss. We are still tallying the damage.

Buzzfeed will immediately cease and desist from further defamatory statements regarding Professor Krauss, and will immediately cease and desist from any further efforts to tortiously interfere with Professor Krauss' contracts. If you
