Have you seen that in the children's letter, they defended Bainco, instead of believing in Noam?

They wrote: "We have also been increasingly distressed to see that instead of feeling happy and relaxed, you feel impoverished. You have even felt the need to hire multiple lawyers to threaten people who you had trusted for years, and who we believe have continued to do their utmost to act in your best interest and to help you navigate your new financial situation. "

And they called Noam's letter "irrational", just to discredit what Noam is revealing.

I think they are thinking about starting a "legal battle" against their father, to achieve whatever they want. They have been manipulating information for that purpose, including emotional ones:

They wrote: "On a personal level, we are heartbroken to feel that we are kept at such a distance from you in your new life. We were thrilled to learn that you had found a new partner, but we were grieved when we began to realize that this meant we are rarely able to see you. Even email and telephone communication has become much more limited."

This is not true. We meet them (Diane, her husband, Avi and two granddaughters in the Wellfleet house last August) in a special trip to see them and we were not invited to stay overnight, although I suggested that I wouldn't like Noam to drive back in the same day (not a word from them suggesting that we could stay for the night). In a recent trip to Mexico (in an event with Lawrence Krauss), in the middle of an intense agenda, we took time to see them (Diane, her husband and their daughter). Harry and his family stayed with us in the Cambridge apartment several times. Diane visited us in the apartment. Avi went there several times (recently I heard from the old maid, that Avi had told her that she (Avi) had never been allowed in our apartment in Cambridge). In the 5 years Noam and I have been married, Harry was the only one to call, on Sundays. After we moved here, he called once and then stopped calling.

Now they are implying that I am preventing them to seeing Noam.

It is surreal.
