The wind then blew out the ducting to the units for the gym and ballet rooms  
There are 5 units total  
Gym x1, Ballet x2, Massage Rm x1  
Due to age the compressor and evap coil will need to be replaced  
The gym unit appears to ok, but the ballet and massage units are toast.  
Propose to replace Massage Rm unit x1, Ballet Rm unit with one larger unit.  
Noting the ceiling in the bathroom will need to be opened up to do this work.  
I will forward proposal once received, I will include gym unit as an option
