Just spoke with Scott and communicated offer to him as follows:

85,000 salary with health insurance benefits, 401k of 3% and potential for bonus

Scott was very turned off by offer. I kept him speaking for a while and he countered 85k and reduced his number from 180k to 132.5k which is the middle of the two numbers. He said he would agree to that with the provision for a review every 3 months. I think he would go for 120k as well.

Here is my opinion even though it is unsolicited. He is very smart and can bring a lot to the table.
