Music

Sonos system is really the best because it can work wireless. We counted all the zone where you already had an audio access keypad. But in some bedrooms there are small hifi systems.

Do you also want to replace them by sonos. Or maybe later ?

Do we use the music stored on you mac (it means it has to be on to listen to music, or do we propose a standalone server (1500 €) ?

For the speakers, the small JBL that are on the floor in the living room and office look very small for those rooms. Would you like us to propose Floor standing speaker (like B&O, because good sound and good looking)

Home Theatre

Since we can't run any new cable we'll try Wireless HDMI on the new projector. So we will also have to change : DVD, Receiver, Screen (for a 16/9)
We'll use your ipad to control It
