Not sure what you mean Jeffrey by "fix the fees"? Fees are a direct result of the amount of time spent and I am not sure there really is any way to truly calculate what the amount of time spent will be. Too much uncertainty on this one and some of which is out of our control. We will, of course, do everything in our power to be as efficient as possible.

I suspect that come the end of August our time/fees from August (hearing and prep and now the additional briefing etc) will exceed the approximately \$100,000 which is currently in your trust account. Please send another \$100,000 to our firm's trust account now which I certainly hope will cover all the work related to the Judge's briefing schedule and the papers required for your Motion to Intervene and leave some leftover as this 3771 matter continues.

Jeffrey: we did not have a full discussion after the hearing about our strategy going forward. I did mention my fears about what could happen and that you should intervene to protect your privileges.

Scott has asked me to write to you to get your thoughts on this. Jeffrey, you will recall when you, me and Scott spoke back in middle July we said that we felt comfortable that the then roughly \$100,000 that would be left in trust after the outstanding balance through June 30, 2011 was paid, would be sufficient to cover the preparation for and attendance at the hearing. We were right and it was.

As we told you in that call if after the hearing it required additional briefing for the Judge that the legal fees could certainly exceed the amount in trust. You understood and we agreed that we would communicate further with you in advance if we thought the circumstances were such that we would exceed the trust remainder. With the Judge's briefing schedule which requires us to file first and then file a reply plus you now intervening and us having to do that work too, there is no doubt that we will well exceed what we currently have in trust. I tell you this now so that we don't have the same problems we had back in June and July.

If for some reason you don't want us to handle the initial post-hearing filing, the reply or the additional work related to your intervention, please let us know immediately as the deadlines are approaching and you should then have someone else do it. If you understand that our work has now significantly increased following the hearing, I would ask that you reach out to Scott and make arrangements to place additional funds into our firm's trust account.

I and/or Scott would be happy to answer any additional questions you may have. What we are trying to avoid is any problems like we collectively had last time as it was certainly uncomfortable for both you and for us.

I know your cases seem never ending and this must frustrate you. But as you are aware these people keep getting big paydays so they are relentless in continuing to pursue you. You are a big juicy target to them. So we need to fight them and get them to back off.
