i just spoke with anthony barrett and he has been dealing with Penn regarding the labor for 2G
Anthony did not have an exact figure yet but said he has accumulated about 10,000 in labor costs in addition
to the cost of the tub which he purchased which cost approximately 1,300.

The total additional expenses for apt 2G from this email is 25,271.29
