Hi Sultan bin Sulayem,

Trust all is well...

I was recommended to contact you, as you may be able to assist me in Gabon in securing meeting with the president or the relevant government officials to discuss a number of issues....

These are the few themes we would be interested to discuss with Gabon. The main ones relates to the following: We are a leading mining bank and Gabon has one of the largest iron ore mine in West Africa, Belinga. The government awarded the deal in 2006 to a Chinese company, China National Machinery and Equipment Import and Export Corp (CMEC), but no work has been done beyond feasibility studies.
