We have some questions that we need answered so that we can finalize the "Southern" application. Below, please find sections lifted from the Business Summary which need clarification or confirmation from you:

1. "Mr. Jeffrey Epstein is the President and sole shareholder of an existing Economic Development Commission ("EDC") beneficiary, Financial Trust Company, Inc.
