Noam and Rich,

As I have conveyed to Rich, Harry is prepared to resolve the dispute regarding the Marital Trusts on the following general terms: (1) the trusts will pay you a fixed sum annually of \$100,000; (2) Max will resign as trustee, and Harry will appoint a new professional trustee to take his place; and (3) mutual releases will be exchanged. With respect to (1), the \$100,000 payment we are proposing would include the income distribution to which you are entitled currently. If in any given year the income from the trust exceeds \$100,000, you would
