based on this pricing we should change our current fueling process  
it is a shame after 5.5 years we are first learning of this opportunity

my last fuel purchase pricing in december was 3.99 for premium vs ayh cost 3.79 and 4.03 for diesel vs ayh cost 4.01

as you clearly pointed out the barge and labor costs easily adds \$1,500 to each 1500-3000 gallon (3000 max capacity of existing fuel truck) fuel purchase which increases our cost by another 0.50 to 1.00 per gallon

i spoke with Bill Bolke senior and Brice on Friday about their mechanic Carlos coming over to LSJ to look at repairs to our fuel truck. When we explained repairs he seemed to be unfazed and thought it was very fixable as their mechanic Carlos has rebuilt trucks from scratch. He also indicated repairs would not be so costly (rather vague but not the disaster Brice presents). I mistakenly left the conversation that Brice would coordinate the planning of Carlos to visit LSJ if he had time this past weekend. When i followed up with Brice on Friday and Monday he said he has tried to get in touch with Bolke but had no luck (which i do not believe). Bolke also suggested using Roy's mechanic to fix truck. I am concerned that Brice continues to push his people (bob kassner) instead of hiring the most suitable person to deal with our issues.

The current wholesale prices for Premium Gasoline and ULS Diesel respectively are \$3.79 and \$4.01. The retail prices are Premium- \$5.279, and Diesel-4.989.
