On Wednesday, March 6, 2013, [REDACTED] wrote:

Jeffrey, I hope all is well.

I think we have started to narrow in on a diamond. I have been working with CORA (www.corainternational.com). We met them through a mutual friend. I have shopped their prices around and they seem to be equal to or better, but as I have learned this is a very difficult market to price with so many factors in each stone.

The GIA report is below on the diamond they have recommended for [REDACTED]. It's a beautiful diamond and amazing setting. As imagined they came in a little above the price range I gave them but after spending an hour with them and not committing they started to soften up a little more. They asked for \$45K. The range I gave them was 30-40K. At the end he said he would speak to his partner (good cop bad cop routine) about making this work in our range (at 40 I'm assuming). Possibly including both of our wedding bands into the price.

Do you think this is a good price for the below stone, plus setting and wedding bands?

Below is the report and some pictures of the stone on [REDACTED] (The ring she is wearing is a temp ring). There is also a picture of the setting but with a different diamond.
