Please see my attached draft of our response to TRT Leasing's purported termination letter. Please let me and Larry know if this letter is acceptable. If not I will make any requested changes. If so, Larry please sign and email to TRT Leasing using the email address indicated on the letter. This follows the notice provision in the Purchase Agreement.

Also, should we fund the full purchase price with the new escrow agent now, so we can say we are ready to close? That would be \$5,935,000, plus \$3,000 which is one half of the escrow fee and another \$2,000 to cover the costs of International Registry recordation. If so, I will tell Rich and at the same time instruct the old Escrow Agent to send us back our \$350,000 Deposit. We did not yet pull that deposit because I did not want to be in technical breach of Purchase Agreement. Once we wire to full amount to the new Escrow Agent, I will pull back the \$350,000.

I wanted to get this drafted as soon as possible so I have not driven in to the office yet. I will await Jeffrey's response before I leave the house in case I have to make any revisions. Please let me know. Thanks.
