Hi. The attachment shows that, even under the most favorable conditions in the deferral context (20 year deferral of tax on Tufts gain but full TRA benefits beginning in 21<sup>st</sup> year at a 7.5% discount rate), the value of TRA benefit is \$16.5 million for Leon. Other than by altering the discount rate and the tax rates, I don't think the TRA benefit in the deferral (guarantee) scenario will get much better. I will leave to you to determine whether that might be enough to overcome the non-tax aspects of the guarantee. Let me know if you want to discuss.
